MEMORANDUM OF COOPERATION BETWEEN
AGRICULTURAL UNIVERSITY OF TIRANA
AND
COMMUNE OF GIOIA DEL COLLE

Agricultural University of Tirana and Commune of Gioia Del Colle hereinafter referred to as Parties, based on the partnership request received by email from the Mayor of Gioia Del Cole, on 19.08.2024, to participate in the announcement of Puglia Region "L.R. 20/2003 "Partenariato per la Cooperazione" - D.G.R. n. 1113 del 31/07/2024 "Linee d'indirizzo per la predisposizione dell'avviso pubblico 2024" - Approvazione e emanazione Avviso Pubblico 2024 "Invito a presentare proposte progettuali" per la concessione di contributi (Allegati A e B) e approvazione modulistica. (N. 00228 del 02/08/2024 del Registro delle Determinazioni della AOO 144 Dipartimento Sviluppo Economico - Sez. Relazioni Internazionali); with the project entitled "PROspettive di Filiera casearie ad ImpaTto 0 - "PROFIT 0", the project has been assigned the CUP code: B64H24001170003, after this proposal has been accepted for funding

Parties agreed on the following:

Article 1

Partnership on the project proposal titled: "PROspettive di Filiera casearie ad ImpaTto 0 - "PROFIT 0", of 12 months from the moment of being accepted for funding. the project has been assigned the CUP code: B64H24001170003.

Article 2

Cooperation will be focused on realizing and reaching the objectives from both sides on activities 1, 2 and 3.

Article 3

Participation in the call will not include any financial obligation.

Article 4

Agricultural University of Tirana, in the quality of the project partner, with offer support in terms of using school, laboratory and agricultural areas as well human resources for implementation of project activities.

Article 5

Monetary participation of our institution will be realized by offering our human resources (2 employees from Faculty of Biotechnology and Food), to work on the achievement and implementing of activities mentioned on article 3 with a total of € 2.000,00 (two thousand euro/00). This cofinancing will be calculated based on monthly payments of engagement personnel.

Article 6

Commune of Gioia Del Colle, in the quality of project coordinator, will provide and make available the necessary funds for realizing aims and objectives of the project. These funds include the following:

1. For logistic services, in order to achieve the objectives of activity 1, funds available for the Agricultural University of Tirana, are in total of € 1.730,00 (one thousand seven hundred and thirty thousand euro/00).
2. For innovation in technology, in order to achieve the objective of activity 2, funds available for the Agricultural University of Tirana, are in total of € 1.770,00 (one thousand seven hundred and seventy thousand euro /00).
3. For promotion and publicity of project activities, funds available for the Agricultural University of Tirana, are in total of € 700,00 (seven hundred euro/00).
4. For personnel payment, 2 engaged persons from the Faculty of Biotechnology and Food, in order to achieve the objectives of activities 1, 2 and 3 funds available for the Agricultural University of Tirana, are in total of € 2.750,00 (two thousand seven hundred and fifty thousand euro/00), divided in: € 1.000,00 (one thousand euro/00) for activity 1, € 750,00 (seven hundred and fifty thousand euro/00) for activity 2, and € 1.000,00 (one thousand/00) for activity 3.

Article 7

The parties agree that this Cooperation Agreement is a basic document and preliminary discussions will be held regarding its amendments, supplements as well as other specific agreements reached between the parties. Any clause of this Agreement may be amended or revoked at any time after consultation and mutual understanding between the parties.

Article 8

The parties have the obligation to behave fairly towards each other. This means, among other things, that the parties, while fulfilling their mutual obligations and exercising their activity, do not harm each other's interests. Disputes that may arise between the parties are resolved in a spirit of understanding and negotiations between them.

Article 9

This Agreement is signed in 4 (four) copies, in the Albanian language, two for each Party, of equal value, and enters into force at the moment of signing.
